COMPETITOR INFORMATION:

- Run under the rules of the NZ Sheep Dog Trials Association.
- Sheep will be worked before the trial and should be quiet and manageable.
- Dogs will run in catalogue order, however the Committee reserves the right to vary the order of running.
- Any Competitor five minutes late after being called may forfeit the run.
- The Judge will call off any dog causing distress to sheep.
- An information sheet will be sent out with the draw closer to the show.
- Prize money may be cash and / or product.
- Enter dogs in preferred order.
- Should entries exceed the number that can be accommodated, selection will be made from those with multiple entries and last to enter.

LEGAL LIABILITY:

The Association's policy does not cover competitors or exhibitors.

PROTEST:

Any protest must be made within 1 hour of the completion of the class in writing, signed by the person making the complaint and delivered to the Secretary accompanied by \$200 cash which will be refunded should the protest be upheld.

HEALTH AND SAFETY:

Exhibitors must comply with the appropriate Animal Legislation and the Health and Safety in Employment Act 2016. No person is permitted in any judging ring without express permission from the Head Steward of that ring. Only persons directly responsible for an Exhibit are permitted in the marshalling area.
